### **Small Claims - NJCourts**

Small claims handles cases in which the demand is not more than \$3,000 or \$5,000 if the demand is for the return of a tenant's security deposit These are the monetary limits of small claims If the amount of money you are trying to recover is more than the monetary limits but less than \$15,000, your case
